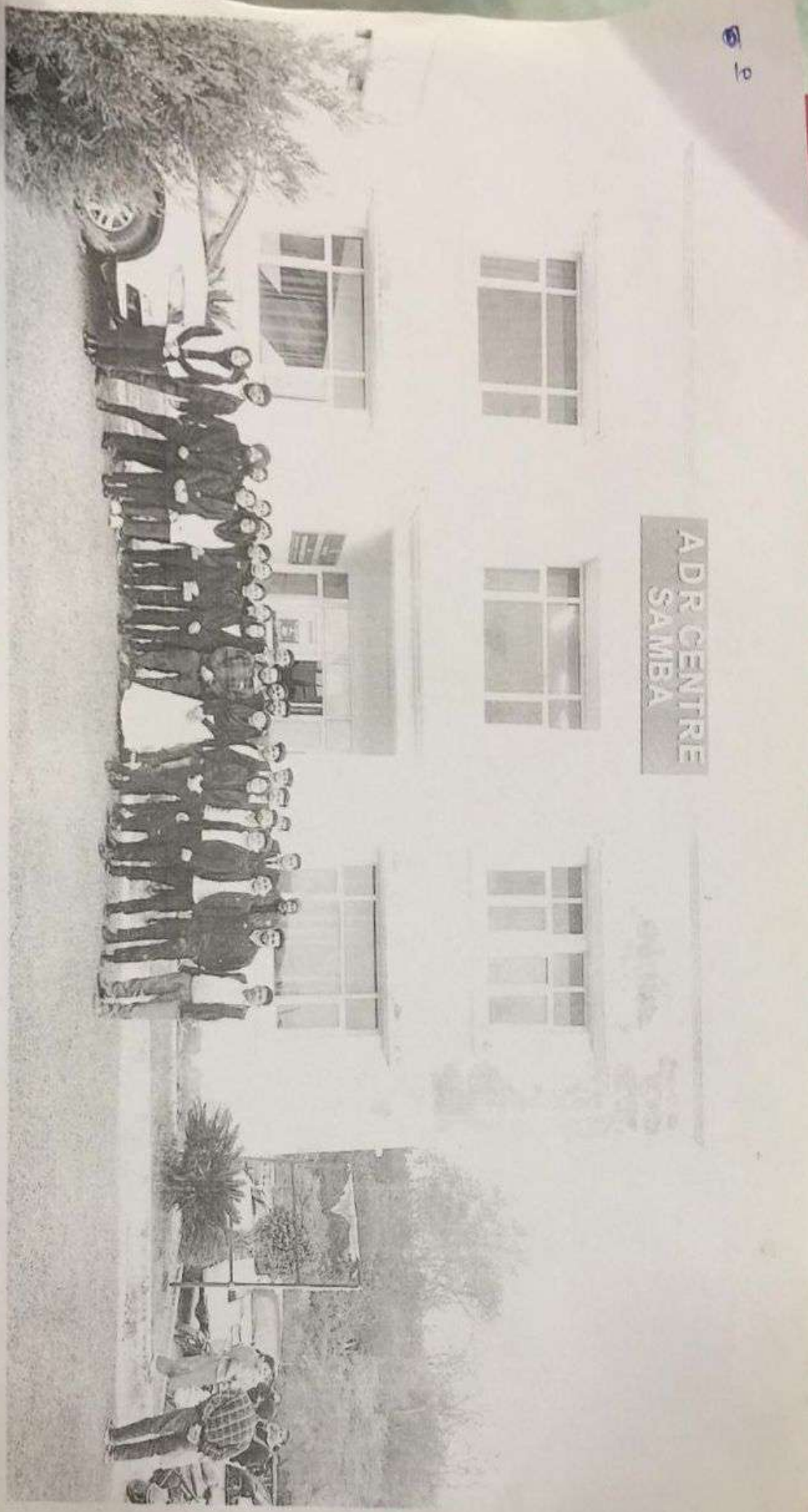

Visit To Lok Adalat At District Court Samba

NALSA along with other legal services institution conducts Lok Adalat. It is one of the alternative dispute resolution, mechanism it is a forum where disputes, cases pending in the court of law or at pre-litigation stages are settled, compromised amicably.

Legal services authority across the country under the aegis of national legal services authority and the leadership of Hon'ble Mr. Justice UU Lalit (executive chairman NALSA and Chief justice of India designated) Organized 3rd National Lok Adalat of the year 2022 where in more than 74 lakhs cases were reported to settle, the total value of the settlement amount is approximately rupees 5 crore.

There was a visit organized by Dogra law college (Legal Aid Cell) in collaboration with District legal services authority Samba. It began with the inauguration ceremony by Miss Sonia Gupta (principle district session judge Samba). After which she explained the need and importance of Lok Adalat and also mentioned that this Lok Adalat also commemorates with Azadi Ka Amrit Mahotsav, after which the National Lok Adalat was declared open.



Lok Adalat at district court Samba was divided under 3 benches; so were students divided into three groups, each group was allotted a bench by our teacher incharge. I was allotted the bench number 1 (conference hall, ADR Samba) which consisted Miss Sonia Gupta (principle district and session judge, Samba), MS Rashi Varma (Additional Munsif Samba), Shri Ajay Gupta (panel lawyer, DALSA Samba.)

This bench dealt with the MACT cases, Bank cases, pre-litigation matters and all the cases referred by district judge Samba. Bench also consisted Advocate Shashi Bhushan sir, along with the other penal lawyers who were keen enough to answer all the queries of the students about MACT cases and told about the historical Sarla Verma Judgment which gives the guidelines to calculate the compensation to be awarded in the various cases. We were also informed about the pre Lok Adalat sessions which wherein a huge amount of matrimonial disputes were already settled.

We were lucky enough to witness the negotiation between the standing council (representing PNB Ramgarh) & Mr. Sukwant followed by some cases like Joti Devi vs NIA which was settled at 15 lakh, Baby Sharma vs. National Insurance which was settled at 9 lakh.

Next we were taken to the ADR centre at district court Samba where secretary DALSA, Mr. Salahuddin Ahmed Sir delivered his lecture about legal services authority ;function and its importance and also highlighted the various methods under ADR mechanism, the discussion was not only restricted to this; he also guided us about various fields of law after which a question answer session was held.

Total 1042 were taken up out of which 813 were settled at amount 1,96,85,8551.

Such visit to institution should be taken up regularly as they help in increasing the practical knowledge.
