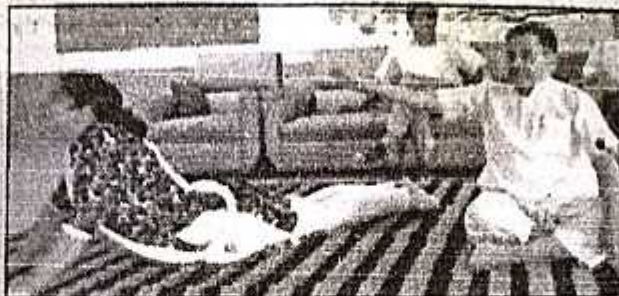
During the interaction the current state of development of Human Rights in the country was dis-

The participants were given light refreshment by the organizers.


