# Alumni Feedbacks Report for the Academic Year 2021-22

It is the practice followed in our Institution to obtain feedback from the Alumni. The various parameters emphasized in these feedback mechanisms are revolving around curriculum, syllabi of courses, course outcomes, programme outcomes, teaching – learning process, etc. The feedback from Alumni is considered as a major resource for the holistic development of an institution.

#### Feedback obtained from Alumni

The 'feedback' from alumni was obtained during the session 2021-22. A good number of alumni responded for the same. The major parameters emphasized in the feedback questionnaire are:

- Do you feel proud to be associated with DLC as Alumni
- Rate development activities organized by the college for your overall development
- Are you willing to contribute to the development of college
- Are your grievances proper handled at the college
- Education imparted at DLC useful and relevant in your present job
- Were the teachers cooperative

Among the feedback collected the category which got above 6 are considered positive response from alumni and accordingly analysis is done. Out of 12 parameters, 6 parameters got 9 out of 10 and rest 6 parameters got 8 and 7 out of 10. This clearly indicates the perception of our institution among our Alumni. All the academic related parameters viz. Syllabus and teaching learning process, attainment of course outcomes, development activities etc got 9 out of 10 in the performance scale.

#### Suggestions given by Alumni

- The teacher's feedback on syllabus and curriculum shows that mere syllabus teaching is not sufficient to bridge the gap between professional skills and academic knowledge.
- Steps to be taken to encourage more number of students to participate in legal related activities.

#### **Action Taken**

# Action taken Report on Feedback from students
