

### SERVICE RULES

These rules called "Dogra Educational Trust Service Rules 2015", Piall come into force with effect from 1" April 2015, and shall apply to the employees of DET.

### 4. DEFINITIONS

- a) DET becein referred to as Educational Trust stands for Dogra Educational Trust and includes
  - i) Dogga College of Education
  - fil Dogra Law College
  - iii) Dogra Degrae College
  - (v) Any other College / wing/ centre enablished by the Management hereinafter with in J&K State or outside I&K
- b) Employees include all those individuals who are employed for carrying out the accepted things to DET and paid salary for the same. They are classified under two heads.
  - Teaching This category includes those entployees who are directly associated will the conduct of classes and/or reactions different courses that are offered under the negrs of DET.

### Non-Teaching

Level I - This category includes all those employees of Dfol who are mainly associated with the day-to-day functioning administration and management of the respinitions in different capacities. This also includes personnel engaged for research 11/0°T, library laboratories, workshops, cavaronment, engineering and similar services of the Colleges Employees falling under this entenory shall be graduates with requisite socialized training at list experience.

Level II - This category includes all those employees of DET who are mightly in-occuping with the applicap, maintenance, functioning and sequency of the institution in different especifies e.g. (a) Office/Lub/Lubrary Assistants, and (b) peops, safai sammelianes, maintenance, care takers drivens, cooks, believes, gardeners, plantings parameters, electricisms, plantographics, garnet operators, mechanics and technically shalled unskilled workers. Such employees shall be appointed on clust actual basis and half also be categorized as contracted employees.

- c) The employees in different wings of DE Franc further classified as under:
  - 1) Ad hoc An Individual possessing necessary qualification for a jubipost too busing little or no experience of service for the particular post shall be terried as all all line employee. Such an employee shall be appointed in a consolidated rates or a storr period of time which will not extend one academic session current financial year. Further make the engaged shall not be entitled to service banefus permissible for regular employees of the institution.
- The processor of arcemployee in a pursualin category (in the time of his/her employment I shall index depend upon the discretion of the management. The amotoyee cannot claim any right for changing his/her entegory once he/she has accepted the employment.
- 4 All employees will be entitled to leave or other sociation benefits as defined for different entegories of employees in 'Dogra Educational Trust Leave Rules 2015'.
- 5. Sensings of those employees, who fall under I(c) of the Class fiell category, except permanent employees can be terminated at any time after administering two warning notes sythout any other formality in case the warnings so administered prove ineffective within the period specified in the said warning notes. However, in case of confirmed employees, the services can be terminated at any time after nolding an enquiry against them after leaving administered time such winning such cases will be decided by the Disciplinary Authority after afterding an opportunity of each time concurred employee.

- 6. Employees of the DET shall not apply for admission to any academic professional course public examination, continue scheme and training programme or for apparaturent to any sob whether in Government or private sector are without specific permission in writing of the Management and completing the prescribed formalities for the same. However, any application subtribed prior almost the DET resulting in appointment elsewhere shall form an exception and could be research sympathetically, if the Competent Authority is informed about the same in writing in the finite of appointment. All employees at the time of appointment will be required under their rules in large of an undertaking on the prescribed proforms format declaring if they have applied any where else for selection, training admissions appointment or job et. Violation of the above will be viewed seriously and may lead to termination of services without my formal notice.
- An employee of the institute who intends to improve his her qualifications by pursuing his her studies in a course (Academic' professional), which is offered in the institute, can do so with the approval of the Management.
- Any improvement in academic and professional qualifications white in service without the prior
  approval of the management will not entitle the incombent to claim any additional benefit
  whatsoever as a matter of right.
- Proceeding on leave frequently, not getting leave pre-smotumed an algeneral policy absenting from the official daty and availing frequent than spells of leave will be taken as acts of will full regreet or daty. This will be seminally taken note of for the continuer apparer.
- (ii) All eligible employees under Employee Provident Fund (EPF) Rules shall be required to deposit not less than 12% of their gross salary under EPF Scheme subject to a maximum of rupess one thousand eight hundred only. The share of the institute firsteed to 12% of the gross salary up to a maximum of rupees one thousand eight hundred only, will be attractible as provided to the P.J. Rules in force.


