The Moot Court work will be on assigned problems with emphasis on the following:

- I) Each student will participate in two Moot Courts and prepare the diary of proposition to be argued in each Moot. Students would use a separate diary for each Moot Court.
- II) In the first meeting of the Moot Groups, the students will be taken to the Library by the Incharge Teacher to acquaint them with the various types of material (like reports, digests, Journals etc.) to be used by them in preparation of the Moot work.
- III) Each student participating in the Moot on a particular day shall submit to the teacher in charge a memorial on the assigned case before arguing the Moot proposition.
